In some areas, building code may require that additional insulation be added above the Attic Stair Insulator Kit to achieve an R-value equal to the surrounding ceiling. To avoid insulation material from spilling into the living space and enable placement of insulation as you exit, unfaced blanket fiberglass should be used. Wood framing may be necessary around the Attic Stair Insulator Kit to support any additional unfaced blanket fiberglass added above it.

All products must be properly installed and meet the prescriptive requirements of the 2009 International Energy Conservation Code (IECC).
