

WOOD SOURCING POLICY

Introduction

Owens Corning is committed to sourcing wood products and materials responsibly. To advance this mission, Owens Corning's policies and procedures that state our minimum sourcing standards, including this Wood Sourcing Policy ("Policy"), and works with suppliers that share its commitment to responsible sourcing.

While Owens Corning understands and respects that there are different legal and cultural environments in which our suppliers conduct their business, this Policy provides a foundation to assist in contracting decisions and supplier selection related to Wood Sourcing. Additional requirements by which to hold our suppliers accountable can be found in our Supplier Code of Conduct and our Human Rights Policy.

Owens Corning commits to source wood products that:

- come from a known source.
- are legally harvested and traded and comply with all relevant regulations.
- do not threaten high conservation value.
- do not come from deforestation or other ecosystem conversion, which leads to biodiversity loss, including that of rare, threatened and endangered species.
- are harvested and produced in a way that recognizes and upholds the rights, titles and customs of Indigenous Peoples and local communities.
- are harvested and produced ensuring that human and worker rights are protected, including decent and humane working conditions and no forced or child labor.

Owens Corning recognizes the importance of collaboration with our suppliers to work together to achieve these shared values.

Wood Policy Scope

This Policy applies to all Owens Corning suppliers of finished goods or production materials (raw materials or components, except packaging or paper and pulp components). It also covers suppliers or vendors who employ processes that include wood or wood components (all products, materials and processes together are collectively referred to as "wood products").

Requirements Incorporated into this Policy

Before accepting purchase orders for wood products from Owens Corning, all Owens Corning suppliers must review, understand, and comply with this Policy and any other applicable sourcing requirements, including the Suppler Code of Conduct. Owens Corning suppliers must also:

• Require their suppliers to comply with this Policy.

- Obtain and retain documents to demonstrate responsible wood sourcing. Such
 documents may include, but are not limited to, wood sourcing traceability evidence and
 third-party wood sourcing certifications ensuring a documented record of the full chainof-custody from harvest to end user.
- Cooperate with any information requests by Owens Corning to confirm compliance with the requirements in this Policy.
- Communicate to Owens Corning any changes it intends to make to product species; country of harvest; Forest Stewardship Council (FSC), the Programme for the Endorsement of Forest Certification (PEFC), or the Sustainable Forestry Initiative (SFI) certifications; or any other changes that could impact compliance with this Policy, prior to implementation of such changes. Any changes should be communicated to the sourcing leader via confirmed email receipt.
- Ensure the following specifications for wood products sold to Owens Corning related to country and region risk (See Appendix 1).
 - o Originates from a country or region of Low Risk.
 - o Originates from a country or region of Medium Risk AND
 - is certified either from: Forest Stewardship Council (FSC), the
 Programme for the Endorsement of Forest Certification (PEFC), or the
 Sustainable Forestry Initiative (SFI); OR
 - ii. comply with annual responsible wood sourcing assessment (See Appendix II)
 - o Originates from a country or area of High Risk and are certified by the Forest Stewardship Council (FSC).

By doing business with Owens Corning, it is a commitment by the supplier that they will meet the requirements through the application of their own management systems including policies, processes, and procedures and it is incumbent upon the supplier to assess and monitor their own policies to ensure conformance to the Policy.

Monitoring Supplier Adherence

Owens Corning can verify alignment to and achievement of our requirements using mechanisms such as self-declarations, due diligence screenings, on-site visits, online assessments, and verifications through third-party audits. Compliance with this Policy will be evaluated by Owens Corning based on risk, including an assessment of size of supplier, types of goods or services being supplied, country of operation and other data where required.

Non-Conformance with Policy

Suppliers who recognize they are not meeting a requirement of this policy or the Owens Corning Supplier Code of Conduct will communicate the breach to Owens Corning and implement improvement actions according to severity of the requirement, and in agreement with Owens Corning. Owens Corning reserves the right to terminate our relationship with any supplier that fails to meet the requirements.

The Responsible Wood Sourcing Assessment applies to all wood products sold to Owens Corning that originates from a country or region of Medium Risk and is not certified either from: Forest Stewardship Council (FSC), the Programme for the Endorsement of Forest Certification (PEFC), or the Sustainable Foresty Initiative (SFI).

- The organization has a:
 - o formalized wood sourcing policy.
 - o process for assessing and managing wood sourcing risks.
 - o process for engaging its supply chain, to ensure compliance with Owens Corning's responsible wood sourcing requirements.
 - o mechanism to map all wood products sold to Owens Corning back to the forest of origin.
