Other Information	<p>While mineral wool may cause temporary skin and mucous membranes itching due to the mechanical abrasion effects of fibers, it does not meet the new classification definition of "irritant" contained in the OSHA HCS 29 CFR 1910.1200, Appendix A. OSHA now specifically defines an irritant as "a reversible inflammatory effect on living tissue by chemical action..." Owens Corning mineral wool is an inert material and does not interact chemically with the skin or mucous membranes</p>

Engineering Controls
